As the Mayor of the Municipality of Prince, I urge you and your government to reconsider any policy or strategy within the forthcoming "Climate Change Action Plan" that would force my residents and businesses to replace the most affordable energy option, natural gas, with more expensive options. Natural gas is a critical partner fuel in a lower-carbon future.

Residents in my community have been working with Union Gas for many years to get access to natural gas. Up until recently we were hopeful that Union Gas would be successful in the OEB's generic hearings in seeking approval for their proposal to provide natural gas service to our community but it appears this proposal may be at risk as a result of your action plan. As evidence of this environmental group Environmental Defence and the Canadian Propane Association have already issued a letter to the Ontario Energy Board asking to stop the hearings on expanding natural gas to new communities until there is further clarity on the future of natural gas in this province. A further delay in this process means a further delay in my residents having access to this new clean and affordable energy option. How can we expect natural gas utilities to invest millions of dollars of scarce capital into new infrastructure when it is reported that your government will eliminate the fuel source by 2050?

Continually we hear from constituents about the challenging fiscal realities of increasing electricity costs in Ontario. The fact is residents in my community are already choosing between their electricity bills and other basic necessities. Any extra delay in bringing affordable natural gas to my community further delays their ability to see energy savings of upwards of \$3,000/year from switching to natural gas. My residents deserve access to affordable natural gas much like the other 80% of Ontarian's who already enjoy access.

To make things worse, the cost of electricity, as you know is scheduled to rise significantly more in the coming years. By contrast, natural gas prices are lower now than they were 10 years ago and we simply cannot afford to ignore that fact. 

At a session of the Council of the Corporation of the County of Renfrew on June 29, 2016 the following resolution was passed,

"Resolution No. DP-CC-16-06-43

WHEREAS in the 2016 Ontario Budget, the Government of Ontario has suspended current intake of applications to the Rural Economic Development Program and has indicated that it plans to integrate the program into the Jobs and Prosperity Fund;

AND WHEREAS the Jobs and Prosperity Fund is narrowly focused and is restricted to private sector organizations and industry partners, which prevents access to funding for rural municipalities and others who formerly benefitted from the Rural Economic Development Program;

AND WHEREAS the emphasis on large projects that meet either of minimum \$5 million or \$10 million in eligible project costs thresholds, will significantly restrict benefits from this fund;

AND WHEREAS in contrast, the Rural Economic Development Program supported a number of capacity building projects including but not limited to "Business Retention and Expansion" and "Downtown Revitalization" projects and Economic Development Strategic Planning projects for small rural municipalities who were looking to improve their local economy;

AND WHEREAS the Jobs and Prosperity Fund is not specifically designated for rural areas, that funds from this program will likely favour more urban areas of the Province;

NOW THEREFORE BE IT RESOLVED THAT the Council of the County of Renfrew is requesting the Government of Ontario to reconsider the suspension and the integration of the Rural Economic Development Program into the Jobs and Prosperity Fund with the view to ensuring that the Rural Economic Development Program stays as an integral funding program of the Province that will support capacity building and foster economic growth in rural municipalities in Ontario;

Dear Mr. Wray,

I am writing in response to your letter of June 6, 2016 and wish to clarify your understanding of governance of the Algoma Public Health Unit.

First, Algoma Public Health did not appoint the Institute of Governance (IOG). The Ministry of Health and Long Term Care (MOHTLC) appointed IOG as a consultant to assist with the appointment process of the District of Algoma Board of Health, and to ensure that tools and guidelines are developed which can be used by all boards of health in Ontario.

The IOG had two specific deliverables for this project:

- i. to support skill based recruitment of the District of Algoma Board of Health
- ii. to develop a toolkit to support skill based boards for all Ontario Boards of Health.

You take issue with points stated in the IOG letter of March 31, 2016 from Mr. Dubois, Executive Director, IOG and Mr. Fleming, Associate, IOG. To be clear they state in the letter "there was a strong consensus among those attending" not as you state "among members". They also state there were nine mayors/representatives of the District of Algoma municipalities present. Further Mr. Dubois advised me that IOG held individual interviews with every head of municipal council in Algoma either in-person or over the phone. He also indicated that a full package of materials that was presented at the March 31, 2016 meeting was sent to the heads of council that were not present at the meeting. Since the meeting and exchange of information was between IOG and the heads of the municipalities of the District of Algoma it may be helpful that the Chair of the Algoma District Municipal Association formally write to IOG with a copy to APH and MOHLTC advising of the position that the Association is taking regarding a skills based board governance model.

As a person who has served on several boards both public and private sector and has studied board governance for many years I am a strong proponent of the skill based board model which is considered a best practice by board governance experts around the world. While I may not agree with the position taken by some mayors who oppose skill based boards I respect their opinion on the issue. Given the current provincial legislation regarding selection of public health board members the use of a skill based model is voluntary.

Rather when a vacancy occurs the APH Board, using the skill based model approach, is asking municipal councils to consider the Board's current needs when they chose their representative to serve on the APH Board. The APH Board recognizes that a council or group of councils may be challenged to find a representative with the skill set the Board is requesting at a particular time. In such situations the Board understands and accepts the decision of the council(s) should they chose a representative who does not fit the requested skill set.

Regarding point two of your letter, I have confirmed with the Ministry its position that section 54 of the *Health Protection and Promotion Act* (HPPA), states that a majority of the members of a board of health constitutes a quorum of the board and that quorum refers to current members of the board of health (i.e. does not include vacant seats).

Regarding point three of your letter APH Board members sign a confidentiality agreement and the APH Code of Conduct when they join the Board. Further there is board policy that requires board members to keep in-camera board documents and discussions confidential whether they attend in person or by electronic means. APH's opinion on this matter has not changed and I reiterate that on occasions where an APH Board member has attended via teleconference the majority of members have attended in person.

Regarding point four the APH Board is using the definition of quorum as advised by MOHLTC. The APH Board does have the authority to pass an annual budget and levy costs to member municipalities. The Ministry expects boards of health and municipalities to meet their obligations under the HPPA. Section 72(8) of the HPPA states that obligated municipalities in a public health unit shall pay for the expenses of the board of health and the medical officer of health in the performance of their duties under the HPPA or any other Act. The Municipality of Wawa is an obligated municipality to which section 72 applies.

Finally, I respectfully and unconditionally reject your opinion regarding the functionally and effectiveness of APH. Through all the governance challenges that APH has faced over the last two years its staff have delivered public health programs and services very effectively and to the benefit of the communities of the District of Algoma. APH Board members have served in an exemplary manner. This board has overseen significant improvements in policy, procedures and practices to ensure effective decisions and to ensure transparency and accountability regarding board business.

On behalf of the APH Board, I encourage the North Algoma municipalities to select a representative. All other municipal seats have been filled and the Board would welcome a representative so that North Algoma municipalities have a voice at the board table and can actively contribute to the work of the APH Board.

Dear Head of Council:

I am pleased to announce that Ontario has commenced a review of the scope and effectiveness of the Ontario Municipal Board (OMB), an important part of the province's land use planning system.

The government is now accepting feedback on a <u>number of topics</u>, which are based on input regarding the OMB's role in Ontario's land use planning system. This includes the feedback received during extensive public and stakeholder consultations on the <u>Smart Growth for Our Communities Act</u> (Bill 73), the update to the <u>Long-term Affordable Housing Strategy</u> and the <u>Co-ordinated Land Use Planning Review</u>.

The government is working to develop proposed recommendations to improve how the OMB works within the broader system of land use planning by releasing a consultation paper in the fall of 2016 for further comment.

In the meantime, the government would like to hear your views on the following topics:

- Jurisdiction and powers: this could include what matters can be appealed and who may appeal them, the use of local appeal bodies and how much deference should be given to municipal decisions.
- Meaningful citizen participation and local perspective: this could include who
 has access to hearings, how to ensure the ability of the public to participate, how
 to ensure that the process is affordable, unrepresented parties and the role of the
 citizen liaison office.
- Clear/predictable decision making: this could include how to ensure fairness, adjudicator education and training and standardized decision format(s).
- Hearing procedures and practices: this could include the formality of hearings, how expert evidence is heard and what evidence should be allowed at hearings.
- Alternative dispute resolution: this could include the use of mediation or other
 alternatives to traditional hearings or adversarial procedures as part of the appeal
 system.
- Timely processes and decision making: this could include the timelines for scheduling hearings and the issuing of decisions.

Comments and suggestions received during all stages of the review, as well as comments already received, will be used to help inform the government of what changes may be needed. There will be further opportunity for input when the consultation paper is released in the fall.

I look forward to our continued collaboration and hearing your views and recommendations as the OMB Review progresses.

RE: <u>Taxation – Impact on Campgrounds</u>

Please be advised that Council for the City of Quinte West, at its meeting on July 11, 2016 passed the following resolution;

Whereas the Canada Revenue Agency (CRA) has decided that some campgrounds are too small to qualify for the small business tax deduction;

And Whereas campgrounds in Ontario have begun receiving calls and letters from CRA warning them of reassessments in part because they are deemed not to qualify for the small business tax deduction since they employ fewer than five people;

And Whereas the camping community provides a source of employment of 15,000 jobs across Ontario and supports economic activity by contributing \$1 billion to Ontario's economy and generating \$294 million in tax revenues;

And Whereas Camping In Ontario, which represents 440 privately-owned campgrounds in Ontario, is working with the Canadian Federation of Independent Business to push the Department of Small Business and Tourism, Finance Canada and the Canada Revenue Agency to implement changes that ensure campgrounds are recognized as small businesses and pay the same taxes as other small businesses;

Now Therefore Be It Resolved that the City of Quinte West recognizes the benefit and values all campgrounds throughout Ontario and in Canada and supports Camping In Ontario's initiative that changes be implemented to ensure campgrounds are recognized as small businesses and pay the same taxes as other small businesses;

And further that a copy of this resolution be forwarded to the Minister of Small Business and Tourism, the local Member of Parliament and all Ontario municipalities for their support. **Carried**
