A bylaw to assign a name to a street
in the Township of Prince

WHEREAS the Township deems it desirable to assign
a name to a certain street in the Township of Prince.

NOW THEREFORE, the Council of the Township of
Prince, pursuant to paragraph 97 of subsection 1 of Section 354
of the Municipal Act, R.S.O. 1970, Chapter 284 ENACTS as follows:

1. STREET NAMED

The street outlined in red on Schedule "A" to this by-law
is hereby given the name "DEANS ROAD" as indicated on
the said Schedule "A".

2. SCHEDULE "A"

3. EFFECTIVE DATE

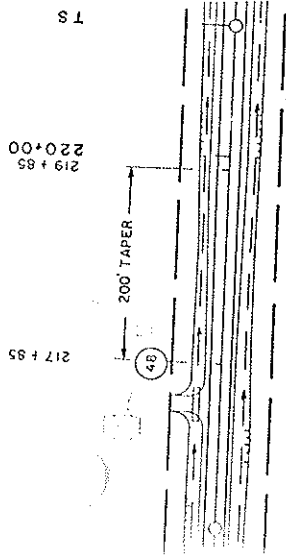
This by-law takes effect on the day of its final passing.
