GENERAL CONDITIONS

THIS IS A LEGALLY BINDING AGREEMENT FOR A PERIOD OF ONE YEAR FROM THE DATE OF SIGNATURE OF THIS AGREEMENT. GENERAL CONDITIONS SPECIFIED BELOW AND ON THE REVERSE OF THIS AGREEMENT.

- Price.** The Customer shall pay to the Company the amount of the invoice as shown on the invoice. Customer shall pay all taxes, fees or other charges and regulations upon the collection, transportation or disposal of waste. The Company shall have the right to increase the service charges as a result of changes in the cost of disposal. The Board scales indicate that Customer's waste exceeds an average of 10% over the Consumer Price Index.
- Payment.** Customer shall pay the charges for the service within ten (10) days from date of invoice. Company may charge interest on overdue payments of 1½% per month or 18% per annum, it being the maximum rate allowed by applicable law. Company may terminate this Agreement if service charges or should credit worthiness of Customer not be acceptable.
- Term.** This Agreement is for a term beginning on the date of signature and shall be automatically renewed from year to year unless terminated in writing by either party. However, that either party may terminate this Agreement at any time by giving not less than 30 days written notice to the other party.
