

TOWNSHIP OF PRINCE
By-law 2001-9

A by-law relating to the use, protection
and regulation of public parks and
recreation areas in the Township of
Prince

THE COUNCIL of the Corporation of the Township of Prince pursuant to Section 207(52) of the Municipal Act and the section 11 of the Public Parks Act, as amended, ENACTS as follows:

1. **INTERPRETATION**

In this by-law:

- (1) "Park" includes any land or premises under the control and/or management of the Township of Prince for park and recreational purposes
- (2) "Township" means the Corporation of the Township of Prince
- (3) "Motor Vehicle" includes an automobile, motorcycle, motor assisted bicycle, and any other vehicle propelled or driven otherwise than by muscular power, and includes a motorized snow vehicle

2. **APPLICABLE LANDS**

This By-law applies to all recreational and park land under the control and management of the Township.

3. **PROHIBITED ACTIVITIES**

In any park, no person shall engage in any of the following activities:

- (1) Operate any motorized vehicle.
- (2) Willfully cause injury to any person or damage to any park property or recreational property by any means whatsoever.
- (3) Conduct themselves in a boisterous or unseemly manner so as to disturb any inhabitant or interfere with the enjoyment of the park or recreation area by any member of the public.
- (4) Post signs or posters.
- (5) Sell or keep for sale any goods, wares, merchandise, confectionery, tobacco or refreshment of any kinds.
- (6) Leave or deposit any ashes, bottle, can, garbage or waste of any kind whatsoever except in a receptacle provided for such purpose
- (7) Park any motor vehicle between 2 a.m. and 6 a.m. or for more than a reasonable length of time at any time
- (8) Hunt, fish, kill or attempt to kill any animal, fish or bird.
- (9) Destroy, damage or disturb the nest or den of any bird or animal.
- (10) Bring an animal into a park unless the animal is held by a leash.

4. **ACTIVITIES - SUBJECT TO APPROVAL**

Unless authorized by the Council of the Township of Prince, in any park, no person shall engage in any of the following activities:

- (1) Perform for reward any art, skill or service.
- (2) Dig or tear up any pavement, grass plot or roadway or any part thereof.
- (3) Cut, destroy or damage in any way any tree, flower, shrub or flower bed.
- (4) Operate any amplifying system, loudspeaker or radio.
- (5) Light or build a fire.
- (6) Moor or beach a boat.

- (7) Place, maintain or allow to remain any coin-operated machine or game of any nature and kind.
- (8) Erect, construct, build or cause to be erected, constructed or built any tent, shelter or building.
- (9) Bring on to the lands of any park, or travel over the lands of any park with any equipment, vehicles or materials of a construction nature.

5. **ANIMAL EXCREMENT**

Persons bringing animals into a park are responsible to clean up and remove the animal excrement of the said animal immediately after dropping has occurred.

6. **SIGNS**

Signs may be erected calling attention to any of the provisions of this By-law or the Public Parks Act. No person shall deface, injure, uproot or remove any sign erected by the Township in a park.

7. **APPLICABLE LAW**

Park users are subject to all applicable municipal, provincial and federal laws and regulations and patrons may be evicted from any park area for any violation of same.

8. **PENALTY**

Every person who contravenes any provision of this By-law is guilty of an offence and is liable, upon conviction, to a fine not exceeding Two Thousand (\$2,000.00) Dollars, exclusive of costs, for each offence, recoverable under the Provincial Offences Act.

9. **EFFECTIVE DATE**

This by-law comes into force on the date of its final passing.
