THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PRINCE HEREBY ENACTS AS FOLLOWS:



BETWEEN:

**TOWNSHIP OF PRINCE**  
hereinafter called the "Township"  
OF THE FIRST PART

-and-

**CHERYLE ERRINGTON and ALLEN COLETTI**  
hereinafter called the "Owners or Intended Owners"  
OF THE SECOND PART

WHEREAS the Owners or Intended Owners are the owners of Part of the Southwest Quarter of Section 32, in the Township of Prince, being the lands described in instrument T-103854.

AND WHEREAS the property known as Part 2, Plan 1R-7774 is owned by the Township of Prince

AND WHEREAS the Owners or Intended Owners must traverse Part 2, Plan 1R-7774 to access their property

AND WHEREAS the road has never been assumed by and therefore is not maintained by, the Township of Prince.

THIS INDENTURE WITNESSETH that in consideration of the covenants between the Parties, the Parties hereto agree as follows:

1. The Owners or Intended Owners acknowledge that the road has not been accepted by the Township of Prince and acknowledge that the Township is not responsible for any construction required on the road, any maintenance or any snow ploughing of the same.
2. The Township however, agrees that this road may be used by the Owners or Intended Owners for access to the property.
3. The Owners or Intended Owners, for themselves, their executors, heirs and assigns, agree that they will make no demand on the Township at any time for maintenance or snow ploughing of the road.
4. Access to the property will not be gained over the road allowance between the properties described on the assessment roll as Roll numbers 495-02 and 503-02.
