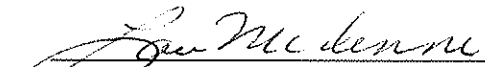
BY-LAW NO. 2001-20

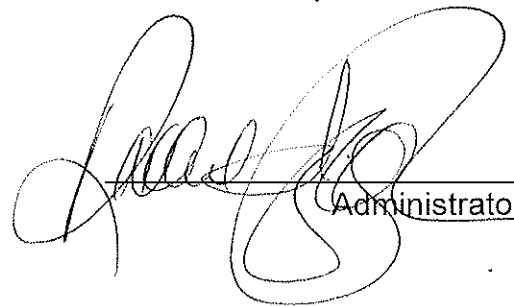
