

THE CORPORATION OF THE TOWNSHIP OF PRINCE

**BY-LAW 2003-16**

**STREET CLOSING:** a by-law to stop up, close and authorize the sale of part of Hill Road as set out on Plan M-164, and parts of a 66 foot right of way in the Delmar Subdivision, Plan M-142, (known as Prince Road and properly known as Prince Lake Road)

WHEREAS the street or parts of a street more particularly hereinafter described have been established as a public street and assumed for public use by by-law 2003-15

NOW THEREFORE the Council of the Corporation of the Township of Prince pursuant to the Municipal Act 2001, and amendments thereto, ENACTS as follows:

1. **STREET CLOSED**

The street or part of a street more particularly described in Schedule "A" to this by-law, having been assumed by the Corporation for public use, is hereby stopped up and closed.

2. **TRANSFER TO ABUTTING OWNERS**

The said street shall be offered to the owners of lands abutting thereon.

3. **EXCHANGE OF PROPERTY**

In exchange for any such conveyances, the abutting owners will convey to the municipality that portion, if any, of their property now occupied by the actual roadway free of any encroachment(s). The municipality will assume the cost of registration of any conveyances to the municipality, while it will be the responsibility of the property owner to register any conveyance by the municipality to him/her/them.


4. **EXECUTION OF DOCUMENTS**






Read the FIRST and SECOND time this 14<sup>th</sup> day of October 2003.
