### McDougall Fuels Locked-In Pricing Plan

You can protect yourself from unpredictable price fluctuations with the McDougall Fuels Locked-In Pricing Plan. With the Locked-In Price Plan you secure an annual price per litre for the propane you use throughout the year at a rate that is competitive and locked-in up front.\*

If the price of propane goes up, no problem - you've got a rate that is guaranteed year-round.

#### Here's how it works:

- To be eligible you must use a minimum of 1500 litres of propane in a 12 month period. (September 1 until August 31)
- If you qualify we will give you a guaranteed price for a maximum of 12 months O.A.C. (September 1 until August 31)
- You'll receive an invoice for every propane purchase, which you will be required to pay in full within 30 days.
- Payments can be made by mailing us your cheque, direct debit from your bank account or at most Canadian Financial Institutions either by Automatic Teller Machines (ATM), by telephone, over the Internet, or in person.
- The Locked-In Pricing Plan will be renewed automatically each year with the new current FIXED PRICE for the upcoming year. No need to worry about missing the enrolment period. Should you not want to continue with the Locked-In Pricing Plan, please call your local office.**
- At the end of your term, we will send you your new guaranteed price for the next heating season.
- The Locked-In price Plan is available to commercial and residential customers.
- September 15th, is the last day to sign up for the locked in pricing.

#### NOTE:

- \* Guaranteed Price contracts are for a maximum of 12 months ending August 31st.
- \* Should you not use the minimum 1500 litres of propane your pricing will convert to our posted price in the following year.
- \* The account must be maintained within our credit term to remain eligible for our Locked-In Pricing Plan.
