CORPORATION OF THE TOWNSHIP OF PRINCE BY-LAW 2004 - 21

ZONING - A by-law to enact an Interim Control By-law concerning certain properties in the Shield Zone

WHEREAS Consent Applications B1 through B33, both inclusive, are applications for consent filed by Superior Wind Energy Inc. to permit leases granting the use of or right in land for a period of greater than 21 years for the generation of electricity by wind energy conversion systems.

AND WHEREAS Section 38 of the Planning Act, RSO 1990, provides that a local municipality may pass a by-law requiring a review or study be completed in respect to the land-use proposed

AND WHEREAS Council has directed that Superior Wind Energy Inc., through a Decision on Applications for Consent B1-2004 through and including B33-2004 supply confirmation that it has met the Federal and Provincial Environmental Assessment requirements prior to issuance of any building permits

THEREFORE THE COUNCIL of the Corporation of the Township of Prince ENACTS the following:

1. PURPOSE

Pursuant to section 38 of the Planning Act, RSO 1990, as amended, no building permits for the erection of wind turbines or supporting equipment shall be issued pending confirmation by Superior Wind Energy Inc. that it has met federal and provincial environmental assessment requirements.

2. DESCRIPTION OF SUBJECT LANDS

Parts of Sections 1, 2, 3, 7, 9, 10, 11, 15, 16, 17, 18, 19, 20, 29 & 30, Township of Prince, as more particularly described in Schedule "A".

3. EXPIRATION

This by-law shall expire on 23 November 2005 or upon confirmation that Federal and Provincial environmental assessment requirements have been met.

4. SCHEDULE "A"

Schedule "A" hereto shall form part of this by-law.

5. **EFFECTIVE DATE**

This by-law shall take effect from the date of its final passing.

6. BY-LAW 77-7 CONTINUES TO APPLY
