**BY-LAW 2013-13**


**Being a by-law to amend by-law  
2013-10 to establish and require  
payment of various fees and charges**

**WHEREAS** by-laws imposing fees and charges are authorized under Part XII of the Municipal Act 2001, section 69 of the Planning Act, R.S.O. 1990, as amended, and the Building Code Act, as amended

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF PRINCE ENACTS THE FOLLOWING:

1. That the charge of \$2.50 per metre<sup>2</sup> for a detached or attached garage or accessory buildings be added onto Schedule "A" of By-law 2013-10.
2. That this by-law takes effect on the date of its passing this 9<sup>th</sup> of April 2013.
